Students completing the alternative licensure program are hired as the teacher of record and placed full-time in their own classrooms. On a daily basis, they apply strategies, methods, and best practices to effectively work with learners from diverse backgrounds. Candidates regularly reflect on and adjust their pedagogical approaches through consultation with their university instructors, supervisors, and mentors. Given that a large proportion of schools in New Mexico serve predominantly Hispanic populations and second-language learners, we provide candidates targeted support to effectively address these students' needs. Candidates are encouraged to share their daily classroom experiences during discussions in their university courses. Additionally, all alternative licensure students enroll in methods courses, where they learn specific accommodations and adaptations for teaching Special Education students and second-language learners in core academic subjects.
