We have multiple site-based teacher education programs in K-12 schools. The teacher candidates work in the classrooms throughout the week to complete their clinical experiences. Methods courses are taught by university faculty and the Level II and III teachers assist with supervision and preparation of teacher candidates. In these authentic K-12 classroom-based clinical experiences, the teacher candidates work with all children including second language learners, those from low income families, and those with disabilities.
